## Introduction to the 2024 Programme

The Centre for Disability Law and Policy (CDLP) at University of Galway is pleased to welcome our in-person and online attendees to the 15th International Disability Law Summer School. This year's event will again follow a hybrid approach, enabling speakers and delegates to participate in-person or online.

Our theme this year is 'Gender and Disability Justice.' At a global level, pushback against the rights of women, girls, and gender minority people are rooted in the same soil and produce the same oppressions that disabled people face, including restrictions on access to justice, legal capacity, independent living, health care, and reproductive rights, barriers to education and employment, increased risk of violence and exploitation, and marginalisation in public debate. These experiences are amplified when individuals hold multiple marginalised identities. To address these challenges, we need to create solidarity within social movements, hold decisionmakers accountable and find new pathways to enforce our collective rights.

The 15th International Disability Law Summer School will explore these challenges by centring the voices of disabled activists and disability rights researchers from around the globe. We will provide space to discuss the institutional and societal changes needed to make the promises of the United Convention on the Rights of Persons with Disabilities a reality and explore the disability justice-informed practices that offer potential for change.

## Shiela May I. Aggarao

Shiela is a woman with visual impairment from the Philippines. She is a feminist with a primary interest in the intersection between gender and disability, and has spent many years working in this area. Presently, Shiela is part of two local



organizations of persons with disabilities, the Nationwide Organization of Visually-Impaired Empowered Ladies (NOVEL), a group of women with visual impairment supporting the empowerment and advocating for the rights of women, girls, and LGBTQIA+ people with disabilities and Life Haven Center for Independent Living, an organization promoting independent living philosophy and concept.

On the global space, she is part of Inclusive Generation Equality Collective, a network of feminists with disabilities and allies fighting for disability and gender rights. During the height of COVID 19 pandemic, Shiela was the peer coordinators for National Capital Region for the project Community-Based Peer Monitoring on the Situation of Women with Disabilities. She worked with other women with disabilities nationwide and they were supported by Commission on Human Rights Gender Equality and Women's Human Rights Center and UNFPA Philippines. In August 2023, NOVEL through Shiela's leadership submitted its first solo shadow report which was supported by Women Enabled International (WEI). Working alongside other Filipino civil society representatives and WEI, Shiela strongly advocated for the rights of Filipino women and girls with disabilities and brought their issues and concerns before the CEDAW Committee during the CEDAW Review of the Philippines last October 2023. Her current work includes leading Wheels of Justice, a project of Life Haven CIL in Valenzuela City supported by the European Union. It aims to build the confidence and assist persons with disabilities to seek justice, strengthen implementation of Batas Pambansa Bilang 344 or Accessibility Law and prosecute its violators. Shiela is an experienced facilitator in community-based inclusive development, and inclusive facilitation conducting training both locally and abroad. She started her journey in climate justice when she joined a team that researched the impact of climate change on rural populations of persons with disabilities in her country. This led to her participation in the first International Youth Climate Delegate Program for the 28th Conference of Parties in Dubai, United Arab Emirates last year. These are Shiela's cornerstones as she leads NOVEL's project on climate change.

## Rebecca Opetsi Alitsi

Rebecca Alitsi is a PhD scholar at the University of Nottingham (UK) where she is pursuing PhD in public policy. She holds a Master of Public Administration degree from the same university and an undergraduate degree in development studies



from Tangaza University (Kenya). Her current research focus is on women with disabilities' access to sexual and reproductive health through the Kenyan healthcare system.

She has championed for disability-inclusive communities in different capacities in East Africa through the state (Kenya) and organisations of persons with disabilities (both national and international). Some outstanding accomplishments include cofounding a disability outreach program at Youth with a Mission in Tanzania and serving as a regional coordinator for the National Council of Persons with Disabilities in Kenya. She received an inclusive development fellowship from the International Federation for Spina Bifida and Hydrocephalus and the International Disability Alliance which enabled her to build the capacity of African organisations of people with disabilities.

## Fiona Anderson

Fiona Anderson holds a Bachelor of Arts Degree in Sociology, Political and Legal Science and a Master's in International Comparative Disability Law and Public Policy from University of Galway. Fiona is a member of the Disability Advisory Committee of IHREC representing psychosocial and mental health disabilities and disability across the board and divide. Fiona is also a current

member of the Mental Health Commission's Stakeholders Forum 2024. Fiona is a country leader with the Global Mental Health Peer Network. Fiona's primary interests revolve around medical and mental health law, discrimination, legal capacity, consent to treatment, advanced healthcare directives and women's healthcare within medical and mental health services and the provision of access to justice and legal representation for persons with disabilities including psychosocial and mental health disabilities. Fiona has been an advocate and activist for over 30 years.

#### Anna Arstein-Kerslake

Professor Anna Arstein-Kerslake is an international leader in the fields of human rights, disability rights, gender justice, and legal personhood. She has published widely in these areas, including her recent sole-authored books, Restoring Voice to People (Cambridge University Press 2017) and Legal Capacity and Gender (Springer 2020). She was the Programme Director of the LLM in International Human Rights Law at the Irish Centre for Human

Rights (ICHR) at University of Galway (2021-22) and the Programme Director for the BA Connect in Human Rights at ICHR (2022-23). She is also the Associate Head of Equality, Diversity and Inclusion at the School of Law and is the Athena SWAN Lead for self-evaluating gender equality at the School of Law. In addition, she is the Vice Dean of Graduate Studies in the College of Business, Public Policy, and Law. She holds a PhD in Law from NUIG, a JD from the City University of New York (CUNY) School of Law, and a BA in Sociology from San Diego State University (SDSU).

## Abu Bakarr Bangura

I am Abu Bakarr Bangura, a Sierra Leonean. I am the Country Representative of African Youth with Disabilities' Network – Sierra Leone with a successful experience in Administration and Communication & Advocacy skills. A Disability Professional with over Ten (10) years of experience working alongside with the

United Nations Partnership on the Rights of Persons with Disabilities (UNPRPD) as the Team Lead of the Physical Disability Aspect; Sight Savers as a Co-Researcher on the Project title: 'Safely at School: School Related Gender Base Violence; Human Rights Commission – Sierra Leone as a member of the Working Group; Freetown Cheshire Home Management Committee as an observer; WE THE 15 as a Commissioner; a member of the Paralympics Committee and The Church of the Latter-Day Saints as Ward President of the Sunday School Tengbeh Town, Hill Station Stake. I earned a Degree in Business Administration from the University of Management & Technology and certificates on Computer software, project and report writing, citizen journalism, organization Development System and Strength from trainings and short courses. I have won multiple awards on disability. I am a Critical Thinker and a strong believer in disability awareness, I am passionate about media campaigns' potential impact on the way we think about and treat disability in Sierra Leone and even beyond.

## Keelin Barry

Keelin Barry is a PhD researcher based at the Irish Centre for Human Rights, University of Galway, Ireland. Since 2020, Keelin has written and worked with Professor Siobhán Mullally, the Special Rapporteur on trafficking in persons, especially women and children. The aim of this work has been to increase the visibility and awareness in international law, policy and practice, of

the intersections of disability and heightened risk to trafficking in persons, faced by persons with disabilities. Keelin's other research and writing has included a focus on the reception conditions of asylum seekers with disabilities in the Irish international protection system, disability and asylum law, as well as multiple submissions to UN Treaty Bodies on disability human rights. Keelin has a particular interest in the human rights protection of asylum seekers and refugees with disabilities, intersectional discrimination, as well as the rights of persons with disabilities in humanitarian crisis and conflict situations.

## Emma Burns

Emma Burns is a researcher and community organiser from County Tipperary, Ireland. She is currently a Research Associate at the CDLP working on a project about children's representative advocacy services in Ireland. She is completing a PhD on the participation of people with intellectual disabilities in public and political life at University of Galway, funded by an Irish Research

Council Government of Ireland scholarship. She has previously worked on various research projects exploring disability and reproductive justice, deinstitutionalisation, inclusive research methods, and the intersection of class and gender in secondary schools. Emma is cofounder and former convenor of Tipp for Choice, a rural women's reproductive justice collective, and in 2018 coordinated the local constituency campaign in support of the referendum on abortion. She is also co-founder and coordinator of The A-Team Youth Club, a grassroots volunteer-facilitated initiative serving almost 200 autistic children and young people in North Tipperary. Service for People with Disabilities. Suzy has worked in print and broadcast media on LGBT and other rights issues both nationally and internationally. An award winning blogger she has an interest in social media and harnessing it for social change and campaigning and more recently has worked on disability and reproductive rights campaigns and capacity building amongst disabled people. She was appointed to the board of Irish Rail by the Minister for Transport, Tourism and Sport and is also a member of the board of the Irish Council for Civil Liberties.

## Theresia Degener

Theresia Degener is professor of law and disability studies at Protestant University of Applied Sciences in Bochum, Germany and director of the Bochum Centre for Disability Studies BODYS. From 2011 to 2018 she was a member (and for the last 2 years the Chair) of the United Nations Committee on

the Rights of Persons with Disabilities. She co-authored the background study of the Convention on the Rights of Persons with Disabilities: Quinn / Degener (2002) Human rights and disability: The current use and future potential of United Nations human rights instruments in the context of disability, OHCHR, United Nations and has participated in drafting the CRPD. ## Cír Doyle

Cír Doyle (They/Them) is a social justice activist. They are disabled both physically and due to multiple Neurodivergencies. They are not formally diagnosed with some of these due to several systematic barriers. Cír is a disabled, trans, queer parent who has too many



labels to name in a quick bio. Previously major campaigns they work with included Bi+ Ireland, Dublin Bay North Repeal, MarRef and other projects spanning multiple social needs. Most recently Cír has chaired the successful Scrap the Green Paper Campaign along side their ongoing work as a cofounder of Neuro Pride Ireland.

## Pam Duncan Glancy

Pam Duncan Glancy was elected as a Scottish Labour MSP representing the Glasgow Region in 2021. Pam served as Scottish Labour's Spokesperson for Social Justice and Social Security until April 2023 when she was appointed Shadow Cabinet Secretary for Education. She is the first permanent wheelchair user to have been elected to the Scottish Parliament. Pam attended Stirling University where she earned a BSc Hons in Psychology and a Masters in Health Psychology. Pam later went on to get a Post Graduate Diploma in Citizenship and Human Rights from Glasgow Caledonian University.

## Eilionóir Flynn

Eilionóir Flynn is an Established Chair in Law and Director of the Centre for Disability Law and Policy, National University of Ireland Galway. Her research focuses on disability and social justice, with a particular emphasis on legal capacity, advocacy and reproductive



justice. She is passionate about educating the next generation of disability rights scholars; and working in active partnership with disabled people's organisations. Her research has received funding awards from the European Research Council, Wellcome Trust and Horizon 2020. Eilionóir regularly advises policy-makers at national and international levels, including providing support to the Secretariat of the UN Committee on the Rights of Persons with Disabilities, and in particular the working group which developed General Comment No. 1.

## Mar Galcerán


María del Mar Galcerán Gadea is a member of the Corts Valencianes, the legislature of the Valencian Community, since September 2023. Mar is a member of the People's Party (PP) and the first Spanish regional legislator with Down syndrome.



She previously worked with the President of the Valencian Government and as a civil servant with the Ministry of Health. She has presented at a number of high profile international events including the 6th World Down Syndrome Congress, the International Congress of AEDES Madrid and Down Syndrome in the 21st Century Global Perspective, Valencia.

## Shelly Gaynor

Shelly is a well-recognised disabled activist in Ireland. She has been involved in disability activism since the age of eighteen. She was been involved in many high-profile campaigns at a national level, including the mobility allowance campaign in 2013 and the 72 hour sleep out outside government buildings in 2012 to protest against a plan to drastically cut Personal Assistance Service hours. Shelly has a Personal Assistant Service for twenty-six years



Shelly joined the board of the Centre for Independent Living (CIL) in the summer of 2017 and was elected chairperson in March 2018. Shelly led the transformation of CIL into ILMI as a national cross-impairment Disabled Persons Organisation when it launched in September 2018. As chairperson, Shelly led many ILMI media campaigns and has spoken at Oireachtas Committee meetings and led political engagement on the ILMI PAS NOW. Shelly frequently leads discussions on Personal Assistance and Assistive Technology with ILMI members and with other allied organisations. Shelly stepped down as chairperson in November 2019 and became employed as ILMI Peer Mentor in 2020 to present. Shelly provides one to one peer mentoring with disabled people to explore their goals and needs and how to navigate systems, including accessing supports for Independent Living such as PAS, Housing and Assistive Technology. Part of her work is supporting disabled people from their individual lived experience into collective peer spaces to become more active in the Movement. She established a PAS peer space and an ILMI Women's space to bring disabled people together online to share experience and fee into the work of ILMI.

## Hannah Gibson

Dr Hannah Gibson is a medical anthropologist whose work over the last 11 years has spanned research on horse-



assisted psychotherapy, surrogacy, mothering, vulnerability, reproductive justice, and disability rights. She is currently a Marie Skłodowska-Curie Fellow based at the Autonomous University of Barcelona where she is conducting research on Spanish intellectually disabled women's diverse experiences of reproductive control (including practices such as forced sterilisation and the use of long-term contraceptives) and autonomy (including motherhood). Through this, she is critically examining what barriers to support exist for them to make informed decisions about their sexual and reproductive health and goals. As a disabled woman herself, Hannah brings a nuanced and embodied perspective to her work. Beyond academia, she has had extensive experience working in the private and public sectors on disability rights in New Zealand, and she regularly writes about chronic illness, medical trauma, stigma, vulnerability, and her service dog Mr Darcy.

Dr John P Gilmore (he/they) is Assistant Professor and Head of Adult General Nursing at UCD School of Nursing, Midwifery and Health Systems. John's work focuses on the intersections of social justice and health, with a specific expertise in sexual and gender minority healthcare. John is a Fulbright HRB Health Impact Scholar and a UCD University for All Faculty Partner.

## Eliona Gjecaj

Eliona Gjecaj is a PHD Candidate in Disability Studies at the University of Iceland, researching the experience of gender-based violence and access to justice for disabled women in Iceland. She holds a First-Class Honours LLM Degree in International and Comparative Disability Law and Policy (2018) from the Centre for Disability Law and Policy of, and BA International Degree on

Sociology & Political Science and Spanish (2017) from National University of Ireland Galway. Since 2019, she is a serving member on the first ever Statutory Disability Advisory Committee in Ireland, appointed by the Irish Human Rights and Equality Commission. Her research interests include access to justice, disability rights, intersectionality, gender equality, inclusive education, and advocacy. 
## Amy Hassett

She worked in research, policy analysis, campaigning, and community organizing fighting for the rights of the most marginalized, including disabled people, immigrants, LGBTQ folks, and people of color. Mia helped organize the Women's March by developing a disability caucus and ensuring Deaf interpreters were represented on stage for the original March. This helped push other progressive organizations and events do more to be more accessible and inclusive and clearly helped to eventually hire the first ASL interpreters at the White House. Mia got numerous awards for her work, including Glamour magazine naming her as one of 2017's Women of the Year Award. She was also recognized by She the People as one of 20 Women of Color in Politics to Watch in 2020 and awarded the 2019 Distinguished Alumni Award from the University of North Carolina (UNC) School of Social Work.


## Elizabeth Kamundia

contributor to the Irish Times and has written ostensibly within the framework of a Traveller feminist perspective. McDonagh's work includes Mainstream, The Baby Doll Project, Stuck, She's Not Mine, and Rings. Rosaleen was appointed to The Irish Human Rights and Equality Commission in May 2020. Within the Commission, Rosaleen is the chair of the Disability Advisory Committee. She is also a member of Aosdana and was part of the BBC's Writers Rooms Hothouse 2021 (June/July).

Rosaleen was commissioned for a feature article in the Irish Times in 2012 responding to Channel 4's series My Big Fat Gypsy Wedding. Her play Mainstream was directed by Olivier Award winner, Jim Culleton, for Fishamble and Project Arts Centre in 2016. In 2018, Fishamble produced Rosaleen's play Running Out of Road in the RHK to mark the first anniversary of Traveller Ethnicity recognition. Rosaleen was writer in residence with Tuti Theatre Company in Adelaide, Australia in 2019. Corrib Theatre Company in Portland Oregon, USA, produced The Prettiest Proud Boy in May 2021. Walls & Windows was commissioned in May 2021 by The Abbey Theatre. Contentious Spaces was commissioned by Project Arts Centre in 2020/2021. Skein Press published a collection of essays titled Unsettled in September 2021.

Rosaleen is currently under Commission from the Abbey Theatre, she is writing an adaptation of Isben's 'A Dolls House'. Rosaleen is also working on two books for Skein Press. The first is a collection of short stories entitled "Contentious Spaces". Her third book "Bearings: A Letter to Amy & Rosie Bridget" is a letter to a young Traveller woman and a letter to a young Disabled woman.

## Siobhán Mullally

Siobhán Mullally is Established Professor of Human Rights Law and Director of the Irish Centre for Human Rights at University of Galway. In 2020, she was appointed as the United Nations Special Rapporteur on Trafficking in Persons, especially women and children.



From 2017-19, Professor Mullally was the President of the Council of Europe treaty monitoring body, the Group of Experts on Action against Trafficking (GRETA), and previously served as 1st Vice-President (2015-17 and Member (2013-19). She was a Commissioner with the Irish Human Rights and Equality Commission (2014-19) and also a member of the Joint Treaty body of the Northern Irish Human Rights Commission and the Irish Human Rights Commission (created by the Good Friday Agreement). She is a member of the Permanent Court of Arbitration, The Hague and was the founding Joint Editor-in-Chief of the Irish Yearbook of International Law (2006-20), published by Hart Bloomsbury, Oxford.

## Donncha O'Connell

Donncha O'Connell is an Established Professor of Law in the School of Law, University of Galway where he has previously served terms as Dean of the Faculty of Law and Head of the School of Law. Currently, he teaches courses on Advocacy, Activism & Public Interest Law, European Human Rights, Policing and Administrative Law. He was a member of the Commission on the Future of Policing. He also served two terms as a

Commissioner of the Law Reform Commission and was a board member of the Legal Aid Board. She is currently working on a PhD on the right to self-determination (legal capacity), and free and informed consent to mental health interventions, as set



forth by the UN Convention on the Rights of Persons with Disabilities (CRPD) at the Centre for Disability Law and Policy, University of Galway. Established in 1999, Disable Society Janakpur (DSJ) is a non-political, non-profit, rights-based organization that focuses on supporting ten types of persons with disabilities in the Madhesh Province of Nepal. Our aim is to ensure no one is excluded, regardless of gender, age, caste, creed, culture, or ethnicity. Established in 2067 (Nepali calendar), BWAN is a national-level, non-profit, non-political, rights-based organization dedicated to protecting and promoting the rights of visually impaired women, and women with disabilities in general. Our work primarily focuses on education, health, employment, and advocacy for women with disabilities. BWAN also provides scholarships for girls and women with disabilities to continue their studies.







## **Stacey Scriver**

Stacey Scriver is a Lecturer in the School of Political Science and Sociology, Discipline of Gender and Women's Studies. Her work focuses broadly on issues of gender equality, with a particular interest in violence against women/gender-based violence. 
## Jennifer Wairimu



Emma Ward is a 21 year old Irish Traveller wheelchair user and disability rights activist. She is a journalist and content creator who is hoping to change the medias perception of both the Irish Traveller and disabled peoples communities in Ireland.









## Benafsha Yaqoobi

Benafsha Yaqoobi, a civic society and human rights activist, founder of The Organization of Rahyab for Rehabilitation Services for the blind (ORRSB) in 2008, an attorney in The Afghan Attorney General's Office from 2017 until 2019, and also Afghanistan Independent Human Rights Commissioner, was born in Kabul, Afghanistan. During her activities, both in the government and in



the civic society, her main goal has been to advocate for the rights of vulnerable categories of the society, incl., women, children, and persons with disabilities. She has 2 master's degrees: one in political sciences and another in International Relations and now, as a PhD Candidate, she is doing her PhD in her 2nd year in an Indian university in the field of political sciences.

## Maryam Madani

Maryam Madani is a media and communications professional in the areas of social inclusion and arts and culture. She is active as a freelance journalist, filmmaker, writer, singer, and disability activist. Maryam is the founder of Disability Pride Ireland, a cross-disability Disabled Persons Organisation, and one of the organisers of Ireland's first Disability Pride and Power Parade which was held in July 2023. She has been a prominent campaigner on issues such as DPOs and the implementation of the CRPD, personal assistance provision, and the 'Scrap the Green Paper' campaign. #### Fire Exits

#### Accessible Bathrooms

The ILAS building has 3 accessible bathrooms, one on each floor. There is a portable hoist which can be used in the ground floor bathroom and a fixed hoist and changing area in the bathroom on the second floor.

#### **COVID** Protocols

Unless medically exempt, we ask all in-person attendees to remain masked indoors, except when dining. Masks will be available each morning at the registration desk.

If you feel unwell during the day, or become symptomatic with COVID/flu like symptoms, you will be escorted by a team member to a separate room and transport to your accommodation will be organised. We can support you with the basic supplies you might need while restricting movements for the required five days. We ask that you do not return to the conference until you have had a negative COVID test. A test can be purchased at pharmacies and many local shops.

#### Permit Parking on Campus

Pay and Display parking is available on campus, and details of this have been issued via email to all delegates. When using Pay and Display parking please ensure you are parked in the blue lined spaces only in the park and ride car park. Clamping is in operation. There are several accessible parking spaces available directly outside ILAS and at two locations close by. You do not need a campus permit to park in these spaces. However, you must display a valid EU disabled parking permit or blue badge or you may be clamped.


#### Quiet/Lactation Room

# Discord

While we don't all get to gather in Galway, we do still want to be able to chat and discuss what we are learning. To that end we have set up a Discord. The link to access the group will be in your email.



#### Channels

These are themed by day – so there are five themed channels. We also have channels for craftivism, general gender and disability stuff and to talk about interests and what work you are doing. This is a place to ask questions and have discussions about the #15thDSS.

#### **Group Purpose**

The Discord exists to allow us to communicate over the Summer School. We hope it will help facilitate some of the chats that normally occur over lunch or between sessions. We hope you will enjoy being part of the group and both benefit from it and contribute to it so others benefit. No experience is too little, and no contribution is too small!

#### **Introducing Yourself**

Once you have joined, please introduce yourself. There is a channel marked for this purpose. This is a good space to share your work. Share as much as you would like to. It is never too late to introduce yourself so don't worry if you did not do so immediately.

Self-promotional posts are encouraged, as long as they relate to the CRPD or gender and disability justice. This includes asking members to like, follow or share your personal social media accounts or blogs, read your journal articles, contribute to or attend your conferences, participate in research etc. Don't be shy, it's what we're here for!

#### Posting

Posts do not need prior moderator approval. This is a space for all Summer School delegates and we can each be responsible for what we post, and our tone. However, do please see the discussion on 'safe space' below.

#### Confidentiality

While you are free to share public information learned in this group widely, be conscious if people are sharing personal experiences that they may not want them to be shared outside the group.

#### **Posting Links**

Posting links to articles, threads, videos, calls for papers, conference details, jobs, etc. that may be of interest to Summer School delegates is encouraged. Please provide a basic information as a 'scene setter' rather than posting a link on its own (e.g. 'Interesting article re gender and disability justice'). This allows group members to judge whether the link is relevant and worth clicking, it promotes discussion, and it allows colleagues to search for the post later. Posts should also include a Content Warning if they contain sensitive material which others might find distressing or difficult.

#### Searching

Given the size of the group and the number of posts, it is easy to miss things. You can search the channels and we encourage it.

#### Duplication

Please check that a comment or article hasn't already been shared so we can keep conversations in one place; a quick search can find previous threads on popular items such as referencing, social media presence, X/Twitter names etc. It can be helpful to read/add to existing discussions rather than to create new ones that inevitably repeat the same information; this helps keep advice in the same place too rather than in multiple threads.

#### **Commenting and Posting Policy**

By participating in this group, you are agreeing to our commenting and posting policy, outlined here. These rules are all about the creation and maintenance of a safe space.

- 1. Please treat your fellow group members with the same respect and understanding you would want to see in your life. When commenting try and add constructive, valuable comments to the conversation. Be friendly, be fair, and treat each other with mutual respect.
- 2. Do not delete posts or comments unless you have been instructed to do so by a moderator. This is so that problematic posts can be a source of learning, to sit with our discomfort if called in/out and also to acknowledge and respect the labour of commentators in replying to the post.
- 3. Do not personally attack other members with comments that are harmful, threatening, or demeaning.
- 4. Trolling, or posting deliberately disruptive statements meant to hijack comment threads or throw discussions off-track are not allowed.

Members who break these rules will receive one warning before being removed from the discord.

#### Safe Space

This group is first and foremost a SAFE SPACE. What do we mean? Racism, ageism, homophobia, sexism, transphobia, ableism or prejudice based on ethnicity, disability, nationality, class, gender, gender presentation, language ability, asylum status or religious affiliation will not be tolerated.

Moderators are not here to limit or direct conversation but are here to ensure this space is safe and productive for all our members. We do not moderate this page continually, there are many posts with multiple threads, and there will inevitably be times when an inappropriate post cannot be immediately addressed by the moderators. If there is a problem, please report the post and wait for a response.

Posts that contain transphobic, homophobic, misogynistic, ableist, racist or similarly offensive material may also be removed, and the member messaged privately; egregious acts will result in immediate removal from the group. In this case, all decisions are at the discretion of the moderating team. While we will always try to explain why a decision has been made, we are under no obligation to defend an action and harassment of moderators will also not be tolerated.

If you feel a member has violated our guidelines, please challenge them or report it. However, do not use it an excuse to violate guidelines in response; and of course, do not harass or bully other users (this includes non- and exmembers). Harassment may include: name calling, using profanity, refusing to leave a member alone if they have requested you do so, creating new threads in order to specifically target one person etc. Do report trolls or abusive commentary (by tagging or sending a message) to a moderator (listed under 'members' in the group page).

Before joining a heated debate, please ask if you can offer anything new to the conversation - dialogue is most effective when people have space to think and learn. If you do want to contribute, try to make it a positive interaction.

#### **Content Warnings**

As noted above, all posts of a sensitive nature should be preceded with a content warning. For example, a content warning could read \*The linked article contains a description of violence or abuse.\* Do please highlight content in your post so that group members can choose to avoid it if they would prefer, but to allow others to read it and you to post without self-censoring.

**Patience and tolerance**...with each other, and with the moderators. We accept that we are all human, and we will all make mistakes within this learning process.

#### What is Craftivism?

#### Crafting + activism = craftivism

Craftivism is a visual, handmade form of activism that usually includes elements of anticapitalism, environmentalism and feminism. Craftivism includes any visual art or design work including but not limited to drawing, painting, street art, collage, embroidery, crochet, knitting, posters and digital art.

Anyone can take part. You do not need knowledge or skills, only a willingness to try and an openness to each other. Craftivism has a long history of use – particularly by women – in human rights campaigns. From the Arpilleras (narrative quilt squares) sewn by Chilean women protesting the injustices of the Pinochet regime to the AIDS memorial



quilt, from the many varied actions of the #JusticeForLB campaign to the Irish abortion rights campaign around the 2018 Referendum, craftivism has lifted voices, started conversations, visually disrupted public arenas, and raised consciousness about social issues and injustices. Craftivists come together in a spirit of openness to create connection with each other and to create visual representations of the injustices that drive us.

"Craftivism is a way of looking at life where voicing opinions through creativity makes your voice stronger, your compassion deeper and your quest for justice more infinite." - Betsy Greer, 2003

#### **Creating Your Craftivism Piece**

The theme of this year's International Disability Law Summer School is "Gender and Disability Justice". For our craftivism project, we invite you to collaborate with us on a piece of visual art and craft inspired by protests and direct action such as the 504 Sit-In, the Disabled People's Direct Action Network (DAN), the Women's March, and the Global Call to Action on Poverty rallies. We invite you to create a dissident body – a protestor, an activist, a crafted version of yourself or someone you admire. You can create a person who looks just like you or a fantastical imaginary avatar. You can choose to add signs and slogans about issues rooted in the intersection of gender and disability justice - a global issue, an issue that affects you locally, or anything in between. Your finished pieces will join others in a collage around the organising image of a disability justice rally, an activism tool that is used across the globe to raise awareness of injustices and unite people in an expression of solidarity.

#### Submitting Your Craftivism Piece

There are two steps that must be completed by everyone **before 5pm on** Wednesday, 19th June

#### **1. Written Description**

Send a written description of your crafted piece by email with the subject line "Craftivism by YOUR NAME" to <u>emma.burns@universityofgalway.ie</u>

- A good written description makes an object accessible by describing essential information about it, including its shape, materials, texture, colours and size.
- Generally, image descriptions should be objective so that people reading it can form their own opinions about what the image means.
- As this is a craftivism piece, you are free to explain any meaning attached to the piece or to describe any emotions you experienced while creating it.
- Try to be concise so that it doesn't take too long for people to absorb all the information.
- Your description will be published with the online digital version of the completed project.

#### 2. Submit Your Piece

- Your image should be a maximum of 25 MBs.

# About the CDLP

#### Research

Representative Advocacy for Children with Intellectual Disabilities in Ireland

This research aims to explore the need for a representative advocacy service for children with intellectual disabilities and their families in Ireland. In this research representative advocacy means individualised, independent support including support to have your views heard, representation in meetings and assistance to understand processes. This research is working with an advisory group of young people, aged 18 - 24 years old, with intellectual disabilities. Focus groups will be conducted with children with intellectual disabilities, aged 9 - 17 and their parents or guardians to document their experiences and what sort of advocacy support they require. The project will also interview key stakeholders in the area including representatives of government departments, advocacy services and children's rights organisations to ascertain their views.

#### Marginalisation, Disability and Candidature in the 2024 Elections

This research focuses on the experiences of disabled candidates who stood in the Irish local and European elections (2024) who hold multiple marginalised identities, including those protected under the nine grounds of The Equal Status Acts 2000-2018 (e.g. disabled women, disabled migrants, disabled travellers, disabled LGBTQ+ candidates). The research is comprised of 1-to-1 qualitative interviews with multiply marginalised disabled people who stood in the 2024 elections, utilising a case study approach detailing a small number of cases. The study aims to understand the intersection of barriers facing these candidates and how Ireland's compliance with Article 29 of the Convention on the Rights of Persons with Disabilities (CRPD) could be better achieved using an intersectional lens.

### Young people who are non-speaking, sometimes speaking or communicate differently and the Assisted Decision-Making (Capacity) Act 2015

This project sets out to learn how young people who are non-speaking, sometimes speaking, or communicate differently can access and use the support agreements under the Assisted Decision - Making (Capacity) Act 2015. It will research international experiences in this area to learn about best practice. It will then work with a small group of young people who are non-speaking, sometimes speaking, or communicate differently and their families to learn about their experience of using or transitioning to Ireland's new system. In doing so it examined the impact of the pandemic-related laws and policies in seven European countries - Ireland, the UK, Spain, France, Sweden, Italy and Germany - on the health and well being of people with disabilities. The Closing the Justice Gap project conducted legal needs surveys with women with intellectual and psychosocial disabilities in Nepal, Fiji, the Philippines, and Indonesia The research project, offers significant new data on the justice gap for women with intellectual and psychosocial disabilities in Asia and the Pacific and provides robust, evidence-based recommendations to close it.
